Dear Ms. Francis:

On behalf of the residents of Mount Pleasant., the Mount Pleasant Advisory Neighborhood Commission (ANC I-E) requests that the reconstruction of Klingle Road southwest of Porter Street begin as soon as weather conditions permit. At the strong insistence of our constituents, ANC 1-E has maintained contact with the Department of Public Works regarding the repair of this road since 1987.

is our understanding that some District of residents have requested that the road be left unrepaired to provide them private access to Rock Creek Park and a jogging, dog walking, and bicycling path. At a recent community meeting Transportation Committee, of the 32 people attendance, only three spoke in favor of closing the road permanently. Of these three, only two are Mount Pleasant residents; the third is a lobbyist for closing Rock Creek Park completely to automobiles. At our December 6 business meeting, request that DPW 1-E voted to begin reconstruction of Klingle Road as soon as possible.

always integral Klingle Road has been an part of the transportation system of the residents of Mount Pleasant and surrounding neighborhoods, as well as police and fire emergency vehicles. It is our access to the Woodley Park, Cathedral and Glover Park areas and beyond. Since its closing, westbound traffic on Porter Street has increased greatly. During the rush hours, cars and buses are regularly backed up to the bottom of the hill, with the resulting exhaust fumes creating an air pollution hazard to people, animals, and trees and a traffic hazard because of impatient drivers.
